## Supplemental Business License Application for Mobile Food Vendor – PRIVATE PROPERTY

Mobile Food Vendors are authorized in accordance with Paramount Municipal Code Chapter 12.42 (previously Chapter 36A) regarding Mobile Food Vendors. Vending on **private property** is only permitted in commercial and manufacturing zones in Paramount, between the hours of 12:00 p.m. and 9:00 p.m., Monday through Sunday. Maximum time for a food vending vehicle on a property is five hours. All other Chapter 12.42 regulations apply. **Approval is subject to Planning Director review and approval.**
